"SCANDINAVIA TODAY"/"DENMARK PRESENTS" NEARS LAUNCH

september will be packed with activities as a range of cultural events mark the beginning of the "Scandinavia Today"/"Denmark presents" program that will run through December of 1983. A number of cultural and commercial events are scheduled in various cities throughout the U.S. starting with the official New York opening of "Scandinavia Today" on Monday, September 13th. Iceland's President Vigdis Finnbogadottir will deliver the keynote address for the official opening at the Alice Tully Hall at the Lincoln Center. At the Cooper-Hewitt Museum the Nordic Design exhibit "Scandinavian Modern: 1880 - 1980" will be opened by H.R.H. Crown Prince Harald of Norway, and at the "National Academy of Design" the exhibition "Poetry and Ecology in Scandinavian Printmaking" will be opened by H.R.H. Prince Bertil of Sweden. As the final event on D-day, H.M. the Queen of Denmark will open the "Art Now" exhibition at the Guggenheim Museum featuring contemporary Scandinavian art and two national exhibits showing works by the Danish painter Asger Jorn and Sweden's Oeyvind Fahlstroem.

Meanwhile, during that same day, H.R.H. the Prince of Denmark will be the guest of honor at a luncheon hosted by the Danish Agricultural Council at the World Trade Center. From there the Prince will proceed to a reception at the American Stock Exchange to commemorate the initial trading on the AMEX of ISS-International Service System Inc. stock, the new name of ISS-International Service System A/S' US subsidiary, Prudential Building Maintenance Corp. Later in the afternoon, at the Cooper Union School, H.R.H. will open the exhibition "Design: The Problem Comes First" arranged by the Federation of Danish Industries and the Danish Design Council. The exhibit features the designer story behind 26 Danish industrial design products.

On Tuesday, September 14th, H.M. the Queen of Denmark will officially open the presentation "Six Danish Artists of Today" during a reception at the Royal Copenhagen Porcelain/George Jensen Silversmithy store on Madison Avenue, in which the artists take part surrounded by their own works of art and craft in this most appropriate setting.

The Prince of Denmark's Export Award will be presented to Mr. Robert W. Darvin of Scandinavian Design/Scandinavian Gallery by H.R.H. the Prince, on Tuesday September 14th during a press reception at Tavern on the Green.

In addition to their New York visit, H.M. the Queen and H.R.H. the Prince will be travelling to Washington, D.C. and Minneapolis to attend and inaugurate a series of "Scandinavia Today"/"Denmark Presents" cultural and commercial programs in those cities.

Inspired by the year-long official promotion, many companies and retail stores are eagerly boosting their own promotion for Danish products, notably furniture stores scattered along the Eastern Seaboard. Wim & Karen Scandinavian Furniture, in New York City, will on September 14th host a reception for U.S. and Danish reporters, interior designers and key people within the furniture industry. Department stores such as Garfinckel's in Washington, D.C., and Dayton's in Minneapolis will, through campaigns during the fall season, gear their promotions towards articles imported from Scandinavia. Danish foods and beverages will likewise be on prominent display at a variety of delicatessen and specialty stores that cater to a gourmet clientele. In Minneapolis a special "Denmark Food Festival" will be the highlight.

The "DENMARK PRESENTS" display material offered free of charge through the Danish Consulate General has met with an overwhelming response from the trade perceiving the stylish red/white banners, signs and posters as an effective, attractive way to highlight Danish products. Chamber members wishing to order this display material may contact the Consulate for order forms.

Finally, the Public Broadcasting System will be airing a gala concert by the Minneapolis Symphony Orchestra, including performances by Victor Borge, Birgit Nielson, Liv Ulman and other prominent Scandinavian artists. The program will be aired as part of PBS' Great Performances series, and can be seen throughout the NY area on Channel 13, on Monday, September 13th at 8 p.m.



NEXT CHAMBER MEETING

The Danish American Chamber of Commerce has accepted an invitation to hold a meeting on Monday, September 27, 1982 on board the 35,000 ton MS Scandinavia, berthed in New York harbor. This ship takes 1,600 passengers, with their automobiles, and belongs to Scandinavian World Cruises, a wholly-owned subsidiary of Denmark's DFDS (United Steamship Lines). See DACC Newsletters No. 1 and 3 for more details on this new shipping line. This will be a joint meeting of the Scandinavian chambers. JOINT DANISH-SWEDISH EXHIBIT SCHEDULED FOR U.S. BOAT SHOWS

Twenty-six Danish and Swedish companies have teamed up to present a group exhibit of boats and products at three major boat shows.

A wide range of boats and products from these two maritime nations will be displayed at the International Marine Trades Exhibit and Conference in Chicago Sept. 30 - Oct. 3, the Southern California Sailboat Show in Long Beach Oct. 22 - 31 and the Miami International Boat Show Feb. 17 - 23, 1983.

A majority of the 26 companies will be entering the U.S. market for the first time, hoping to attract importers, distributors and sales agents. The Danish participants include:

Scanpilot (instrumentation)
LM Glasfiber (motor sailers)
Coronet (power boats and motor yachts)
Bianca (ocean going cruisers/racers)
Hempels (sailing wear)
Viking (safety equipment)

Products for commercial use include electronic navigation and steering systems, pumps and water pressure systems, propellers, stoves and heaters, safety equipment and solid state, thermoelectric coolers and refrigerators.

Boats include sailing dinghies, trimarans, motorboats and motor-sailers, sailboats and fishing boats.

The exhibits are being coordinated by the Trade Office of the Consulate General of Denmark in New York and by the Swedish Trade Office in New York.

INTERCONTINENTAL HOTELS AND SCANTICON INTERNATIONAL IN JOINT VENTURE TO DEVELOP AND OPERATE EXECUTIVE CONFERENCE CENTERS THROUGHOUT THE WORLD

Intercontinental Hotels Corporation and Scanticon International, Inc. have formed Scanticon Corporation, a joint venture to develop and operate Executive Conference Centers in the US and throughout the world, is the new company 80 % owned by Intercontinental Hotels Corporation and 20 % by Jorgen Roed, the founder and owner of

Scanticon International. Mr. Roed was named President and Chief Executive Officer and a Director of Scanticon Corporation. He will retain his position as President and Chief Executive Officer of International, a firm specializing in developing and Conference Centers and Hotels. Scanticon International Managing Conference Centers and Hotels. Scanticon International Operates Scanticon-Princeton, a \$40 million, 300 room Executive Operates Center and Hotel, which opened last September, and will Conference Center and Hotel, which opened last September, and will continue to be operated by Scanticon International independently of the new company.

Scanticon Corporation will be a subsidiary of Intercontinental Hotels and will be headquartered in Princeton, New Jersey. Plans call for the development of 10-15 Conference Centers in the next 10 years. Each will be an Executive Conference Center, similar in concept to Scanticon-Princeton: a deluxe meeting facility with meeting rooms as the nucleus, complimented by first class hotel accommodations, restaurants and recreational facilities.

The Conference Centers are equipped with the most advanced audiovisual communications technology. A staff of highly qualified technical and service personnel are on-hand to operate the equipment and assist conference groups.

Intercontinental Hotels Corporation includes 107 hotels in 50 countries. It is part of Grand Metropolitan, one of the largest companies in the United Kingdom with total annual sales in excess of \$6 billion.

THE DANISH ECONOMY (DEN DANSKE PROVINSBANK)

It has been a very hot summer in Denmark in more than one way.

The temperatures have been reaching the upper eighties, and the arguments in the economic and political discussions have been heating up.

The background for the intensified debate is the outlook for a further deterioration in the economic situation in Denmark. It is now recognized among a number of Danish political leaders that the situation is very severe, and not even a strong economic recovery in the Western world will solve the economic disequilibrium problems Denmark is facing.

The balance of payments is expected to show a deficit of Dkr. 16 - 18 billions for 1982 against Dkr. 13 billion in 1981. A major part of the deficit is a result of the increased interest payments on the foreign debt. A substantial part of the foreign debt is denominated in dollars, and the combination of high interest rates in the United States and increasing international value of the dollar is imposing problems for the balance of payments.

It has been a goal for the economic policy to strengthen the ability to compete in the foreign markets. The strengthening has been carried to compete in the foreign markets. The Danish krone, and further, out through a number of devaluations of the Danish krone, and further, the Government has tried to keep down the increase in salaries. A number of municipalities have announced that the tax rate for 1983 is going to increase considerably. The largest increase announced so far is five per cent. The recent publication of the expected deficit on the public budgets for 1983 might indicate that the Government will be forced to increase federal taxes even further than anticipated. The expected deficit is published as Dkr. 74 billions but among prominent economists it is feared that the deficit might reach Dkr. 90 billions. The financing of a deficit of this magnitude makes it almost impossible to believe that the interest rates in Denmark will decrease in the period ahead, despite the tendency to decreasing interest rates in the U.S. and other countries.

As indicated above, the situation in Denmark is very severe and it is becoming more and more evident that what is needed is a joint effort by a majority group in Folketinget.

SCANFORM GALLERY

Scanform, a new Soho gallery specializing in Scandinavian design and decorative arts, opens its doors to the public on Tuesday, September 6, 1982. By featuring Twentieth Century decorative arts from Denmark, Iceland, Finland, Norway and Sweden, owner Eduardo Garrido hopes to familiarize his audience with "Scandinavian design".

In addition to a wide ranging permanent collection of rare objects, objects de vertu, and industrial design pieces, individual artists will display their works for three week periods. Featured Danish artists include Thorvald Bindesboll, Kahler Ipsen, Kaare Klint, and Johan Rohade. Alumina and Holmegaard will be among the Danish factories whose works will be displayed in Scanform Gallery.

All areas of decorative design, ranging from jewelry and ceramics to glass, textiles, and furniture are to appear. The presentations will encompass not only the design classics of yesterday but will also focus on modern works fresh from artists' studios and current industrial design.

Scanform Gallery, at 100 Thompson Street, New York City, is open six days a week, Tuesday through Saturday, 11:00 a.m. to 6:00 p.m., and Sunday 1:00 p.m. to 5:00 p.m.

DENMARK HAS THIRD HIGHEST TAX RATE IN THE WORLD

A study of income tax in Western Europe and U.S.A. has found that French, Swiss and American taxes are the lowest, while Swedish, Portugese and Danish taxes are the highest.

Management Center Europe, a business research concern, surveyed income taxes in 18 countries and found that a married couple in Denmark with 2 children and earning \$100,000.— is left with \$37,000.— after taxes and social security. In France a couple would be left with \$64,000.—, in U.S.A. and Switzerland with \$63,000.— and in Spain with \$62,000.—.

Sweden has the steepest tax rate of all income levels, with a couple earning \$100,000.— ending up with only \$24,000.—. In Portugal such taxpayers are left with \$31,000.— and in Belgium with \$42,000.—. SOURCE: The Wall Street Journal — August 12, 1982.
