DANISH AMERICAN SOCIETY CELEBRATES

On May 18, 1984, Danish American Society will celebrate its 25th anniversary at a Gala Dinner Dance at the Plaza Hotel. At the same event the internationally famous Danish artist and designer Wiinblad will be honored as "Man of the Year".

Danish American Society was established in April, 1959. The Society is a non-profit, non-political membership corporation whose main purpose is to further and enrich Danish-American relations, and to function as a focal point for activities offers assistance and support to other groups with similar objectives.

The first important event sponsored by the Danish American Society took place in 1960 when Their Majesties King Frederik and Queen Ingrid of Denmark were honored at a formal ball at the Waldorf-Astoria. The Royal Danish Ballet provided the entertainment, and 1,200 guests attended the ball.

Another important event was Denmark Day at the World Fair in New York, 1964. Prime Minister and Mrs. Jens Otto Krag were guests of honor.

In 1971 the first annual Christmas Party was given, a tradition that continues every year for members of DAS, their families and friends. The Annual Meeting is held just prior to the Christmas Party.

In 1975 DAS established the "Man of the Year" event which honors a prominent person from the Danish and/or American community who has contributed to the furthering of relations and understanding between Denmark and the US.

In June 1983 a cultural exchange program for young Danish and American performing artists ("DANCE") was established. A Gala Benefit Performance by The Soloists of the Royal Danish Ballet, Peter Martins, and the Martha Graham Dance Company, took place at Carnegie Hall, followed by a Dinner Dance aboard the airplane carrier "Intrepid".

1983 was also the year of the New York City Harbor Festival "A Scandinavian American Salute". The Danish participation was organized by the Danish American Society in co-operation with the Danish American Co-ordinating Council.

PROSPECTS FOR THE DANISH ECONOMY ARE FAIRLY BRIGHT (PRIVATBANKEN)

As a result of a rather steep rise in both exports and domestic demand, the rate of unemployment is not expected to increase in 1984. Domestic demand will be stimulated by rising private fixed investments, increased housing construction, and by larger private consumption. All things considered, the increased economic activity is expected to create well over 20,000 jobs in the private sector, and this will offset the addition to the labor force and the slightly falling rate of employment in the public sector.

Despite accelerating industrial exports the balance of payments is expected to improve only slightly. The reason for this is that the rising activity will be followed by a corresponding increase in imports, including imports of raw materials for stock building, and furthermore that payments on the foreign debt will increase.

An expected fall in the exchange rate of the dollar will have a counterbalancing effect. A fall in the dollar rate will bring about an immediate easing of the balance of payments situation and will reduce the rate of inflation. Thus a fall in the dollar rate will partly offset the rising raw material prices that are foreseen in the wake of the upswing in international business cycles. At the same time the low rate of inflation will result in an - although only slightly - rising take-home pay for most income groups in 1984.

However, a report recently published by the government's own economists forecasts a growth in the balance of payments deficit this year. The government's very pessimistic forecast is primarily due to the fact that estimates on the balance of payments figure are based on the assumption that the dollar will not be weakened this year. A fall in the dollar rate of 10% would improve the balance of payments by approx. D.kr. 2.5 billion. Therefore the dollar-rate assumption is of vital importance when forming an estimate of the Danish economy.

At the end of January the U.S. government presented estimates showing that the dollar is overvalued by well over 30% at present. It would thus be reasonable to assume that the dollar rate will fall this year. And in fact Privatbanken expects a fall in the dollar rate of 10% which will have a beneficial effect on the balance of payments and the rate of inflation.

On balance, prospects for 1984 are fairly bright. The Danish economy will continue to see severe balance of payments problems, but developments will show that the difficulties are not too severe to be solved.

Liberals, gained one seat and now has 10 seats. This means that the government can only muster a total of 87 seats and is thus forced to seek the support of several parties for its economic policy.

The budget for 1984 was tabled again on January 25. It corresponds to the government's original budget tabled on August 17, 1983, as amended after the parliamentary division on the amendment proposals held on December 14 and 15, 1983.

The cyclical estimates of daily benefits, taxes and duties etc. in the budget put to the vote on December 15 were based on the evaluation of market conditions made in October 1983 by the government's own economists.

The recent past has proved that the Danish economy is in a phase of revival, which seems to be stronger and to have come sooner than expected just a few months ago. The relatively great change in the socio-economic evaluation with a larger growth in output implies a reduction of the estimated unemployment rate and an improvement of the government finances in 1984. On this basis a number of amendments have been made in relation to the budget put to the vote in December. These amendments concern mainly the revenue from taxes and duties and the expenditure on unemployment

It is presumed that the budget will be passed practically unchanged. However, the government will probably comply with some of the Social Democrats' demands for increased social expenditure. This may cause the deficit on the government finances in 1984 to become about D.kr. billion larger than provided for in the budget.

At the upcoming international fashion fair in New York, "The New York Pret", on March 4-6, Denmark will be represented by 7 companies showing a wide variety of women's wear, sports- and leisure wear, young fashion, furs, and accessories.

SAS WINS RECOGNITION AS "AIRLINE OF THE YEAR"

On January 19, 1984, Air Transport World awarded SAS the top industry award for "overall excellence" and "outstanding service to the travelling public". Air Transport World is an international trade and consumer magazine. The ceremony took place at the Plaza Hotel.

A lot of praise was showered on SAS as "one of the finest airlines in the world". Rather than give the company all of the special awards the editors decided to award SAS the top honors. The airline was cited for excellence in passenger service, financial management, technical management, market development and industry service personified by CEO Jan Carlzon.

In the fiscal year 1982 SAS had an operating profit of \$24.6 mill. Last year (ending September 30) the profit was \$58.9 mill., one of the best results in the airline industry.

To celebrate the occasion SAS threw a party at Regine's on Park Avenue in New York, inviting some 1,000 friends, associates and contacts. Members of the staff worldwide (20,000) each got a miniature of the award. On the day of the award ceremony all passengers were given free champagne (chocolate in Sweden).

SAS/EASTERN TERMINAL PLANNED FOR JFK

SAS and Eastern Airlines are discussing a terminal partnership in J.F. Kennedy Airport, Jan Carlzon explained during a press meeting at the Plaza Hotel. If the last negotiations are successful SAS will build an eleven-gate terminal at an investment of \$60 mill. Eastern will rent part of it.

The president of SAS explained that a terminal is a good investment both financially and in terms of better passenger service. Travellers from Scandinavia will tag directly on to Eastern's domestic network and avoid the refined horrors of the international arrivals terminal. The terminal can be self-financing without more traffic than at present.

WILL SAS CLOSE SEATTLE OPERATION?

The discussions in business circles here about a prospective closing of the SAS office in Seattle are based on rumours. They spring from a memorandum of understanding between the US and Scandinavian authorities, where the possible establisment of a new SAS gatecity in this country was dependent on the closing of an existing port. Seattle was seen as the most likely candidate. A source in SAS tells us that this part of the memorandum would be challenged in court rather than abandoning Seattle.

NEW SAS SERVICE AT KASTRUP AIRPORT

A special drop-off point for luggage destined for domestic flights has been opened adjacent to customs clearance at international arrivals. SAS will now bring the luggage to the domestic departure hall and onto the connecting domestic flight. This new feature represents a real breakthrough in smoothing the transition from international to domestic flights, often cumbersome and time-consuming in the past.

SCANDINAVIAN BANKS OPEN OFFICES IN CHIGACO

At its Board meeting in Stockholm on February 14, 1984, American Scandinavian Banking Corp., New York, Jointly owned by Christiania Bank og Kreditkasse, Den Danske Bank, Post- och Kreditbanken, PKbanken and Union Bank of Finland, decided to establish an office in Chicago in the spring of 1984. The purpose is to provide better service to the Nordic customers in the Chicago and Midwest area. During recent years the Midwest has experienced a substantial influx of investment from the Nordic countries. (Press Release)

Nordic American Banking Corporation, New York, arnounced the opening of a representative office in Chicago, Illinois, which will be responsible for corporate relationships in the surrounding eleven state area. The office is expected to open for business on March 1, 1984.

Nordic American is owned equally by leading banks in the four Nordic countries. Nordic American's Danish shareholder is Copenhagen Handelsbank. Other partners in the group are: Den norske Creditbank, Norway, Kansallis-Osake-Pankki, Finland, and Svenska Handelsbanken, Sweden.

The office will be managed by Mr. John A. Redding, Senior Vice President, and will be temporarily located in space leased from the Swedish Trade Office at 333 North Michigan Avenue.

Mr. Nelson, President of Nordic American, pointed out that the Midwest represents the largest concentration of Nordic business trade and investment in the U.S. outside the Northeast.

SCANDINAVIAN TRADING CENTER IN FLORIDA

Danish, Norwegian and Swedish business people in Florida are establishing a Scandinavian trade center in Miami. The project, which is aimed at both the North and South American markets, is expected to be completed towards the end of 1984. Florida has experienced a marked interest from Scandinavian businesses who wish to establish themselves in the US. The initiative to establish the center originates in the Danish, Norwegian and Swedish Chambers of Commerce, and the president of the Danish American Chamber of Commerce, Orla Bulow Gercke, is one of the central figures involved in the project.

"The Scandinavian Trading Center" is not a new idea. The Northeastern states already have companies offering import/export and administrative services to Danish and Scandinavian companies. The plans for Florida, however, seem more ambitious, and the organizers intend to finance the project through a Scandinavian bank based in the US.

RUDD INTERNATIONAL AND LABOFA EXPAND ACTIVITIES IN THE US

On May 1, The Rudd International Corporation and Scandinavian Tobacco (owners of Labofa) will have an assembly plant operating in this country. The initiative is a response to the overwhelming interest for the Cyborg chair.

"The Cyborg is now the premier office chair in this country. The success is coming so fast that we have to start US assembly to meet the demands from the market", said Alan von Eggers Rudd in a conversation with DACC Newsletter.

The Danish production cannot keep up with the US demand and the particular specifications of customers. Delays of just 2-3 weeks can hurt the company, said Rudd. The new plant will take away some of the bottlenecks.

The Rudd International Corporation has worked with Danish furniture makers for several years. Some product ideas developed in this country have proved successful in Europe as well. The reason for the co-operation, according to Alan Rudd, is the tremendous know-how, fine craftmanship and technological skill of Danish furniture manufacturers. Rudd International does not sell Danish design, but Danish quality, Rudd emphasizes.

US MARKET AGAIN OPEN FOR FRESH MEAT FROM DENMARK

In January the US market was reopened for fresh Danish meat - pork as well as beef.

The US Department of Agriculture temporarily closed the US borders for fresh Danish meat in the spring of 1982 due to an outbreak of hoof and mouth disease in Denmark.

Meat products - in particular canned ham, which was not included in the embargo - are the largest group of products in the Danish exports to the US. In 1983 Danish exports of meat products amounted to approx. \$160 mill., and an increase to \$200 mill. in 1984 is considered to be within reach.

CANADA CONSIDERS COUNTERVAILING DUTIES ON DANISH LUNCHEON MEATS

In Canada a countervailing duty investigation against consumer-size packaged hams, picnics and similar items from Denmark and Holland was initiated. The complaint against hams and picnics has been eliminated, but the case has been continued against luncheon meat.

DENMARK AGAIN LARGEST SUPPLIER OF CHEESE TO THE USA

In 1983 Danish cheese exports to the US totalled D.kr. 500 mill., and the high rate of exchange means a record high profit for the Danish exporters and dairies.

Denmark's market share in the US is twice that of t.ex. West Germany and France. The volume of cheese exports in 1983 decreased by 10% compared to 1982, but the prices have increased to make up for the difference. The high rate of exchange is another reason why exports to the US have been highly profitable.

The rich 60% Havarti is still the favorite with Americans, followed by Danablu and Castello types and Svenbo, an Emmenthaler type.

The US quota for cheese imported from the EEC countries is 44.000 tons/year. Denmark's share is 17.000 tons which is more than a third.
