However, upon further consideration, it was deemed advisable for any individual to seek his own legal counsel on the matter of his status re this issue of general estate taxes.

WHEN LIBERAL MEANS CONSERVATIVE

While USA recently was visited by the man some call the next prime minister of Denmark - Foreign Minister Uffe Ellemann-Jensen - the residing Poul Schlüter has changed the top of his own conservative party.

Mr. Ellemann-Jensen travelled through New York, Boston, Chicago and San Francisco pitching Denmark as the best place to invest for an American com-pany in the hi-tech field seeking a brigdehead in what some still see as the new Fortress Europe.

His audiences at some twenty meetings didn't seem surprised about his message. After all they have seen the travelling men from just about eleven other countries in the European Community do the same stunt.

But they were surprised to hear him presented to them as the leader of the Danish Liberal Party. And the political oarsman took great care to explain how in Danish politics a Liberal from the party Venstre is a true conservative.

Not to mention that a Danish Conservative often can seem liberal. Under the strain of leading the conservative coalition governing Denmark the Conservative Party seems in the eyes of many commentators to have drifted towards the values of the Social Democrats.

The master mind behind this development left the Danish Government this October. The now former Finance Minister, Palle Simonsen, was generally said not to have any enemies, not even among the Social Democrats. And some would add, he didn't have any friends, either.

His departure lead to the second change among the conservative members of the government. In the eyes of some the Prime Minister Poul Schlüter has succeeded in bringing in some of the younger politicians and yet make it all look more conservative. It didn't quiet the call for an overhaul of the coalition, strained also by the success of the conservative Liberals in the latest polls.

In a brochure just published by the Danish Foreign In a processor the accounting firm Arthur Andersen & Co. Ministry the accompanie tax of 50% only seems to be a minor problem compared to the extremely high personal taxes, which makes life very difficult for foreigners stationed in Denmark.

In a similar survey done in Japan for the Danish Foreign Ministry the Danish investment climate was rated even lower. On behalf of the Danes the company Nomura tracked some 1800 companies and their interests in expanding in the European Market. Only one expressed interest in starting a joint venture

To the Japanese companies the Danish position on the outskirts of the Community is seen as a hindrance. Not surprising the wages were seen by the Japanese as a barrier, too.

The two surveys were ordered as a lead in for the Danish campaign to attract more foreign investments from the two countries. The campaign has a budget of kroner 65 millions.

Both surveys showed the lack of knowledge about Denmark among potential investors. An investor only seems to notice that the corporate tax rate is 50 per cent - and not the extensive tax deductions.

Some results from the surveys have already become anecdotal - like that American business leaders didn't always remember that Denmark 1s a member of the Community.

ROYAL DANISH EXPORT AWARD TO PETER P. LOMBARD

A recent communique from Copenhagen announces that the newest recipient of the prestigious Royal Danish Export Award will be Mr. Peter P. Lombard, President of American United Marine Corporation, Saugus (Boston), Massachusetts. The award is made to individual leaders of industry who have made outstanding contributions to the international promotion of Danish business interests.

The award will be formally presented on November 15 at his account formally presented of at his official residence by the Consul General of Denmark, Mr. Leif Donde, during a reception held in Mr. Lombard's honor.

SAS/SWISSAIR IN QUALITY ALLIANCE

SAS and Swissair have agreed on a comprehensive alliance to create a competitive, worldwide traf-fic and travel service system with a solid base in the European market.

According to the agreement, the two companies will develop a partnership covering traffic systems and travel products, hotels, trading activities, flight kitchens and restaurant operations, fleet planning, aircraft maintenance, data and telecommunication systems and staff training.

The cooperation will be confirmed also through a mutual financial engagement between the parties in the range of five to ten per cent, to be completed during 1990.

Preparations for the alliance have taken place over an extended period of time in which a number of joint committees have evaluated the potential of the cooperation. Initially, it is estimated that the two companies can achieve some \$30 million in annual result improvements by combining resources in a number of areas.

In terms of joint products, SAS and Swissair will evaluate opportunities to establish mutual quality standards in such areas as check-in times, punctuality, through check-in, airport lounges, and credit cards. The goal is for both Scandinavian and Swiss customers to "feel at home" in one another's traffic systems.

SAS and Swissair will further review opportunities to integrate each other's hotels in the global travel service system. Swissair has 13 hotels, while SAS has 128 hotels, including 23 of its own plus a 40 per cent share in the 105 hotels in the InterContinental chain since last spring.


The two companies will also coordinate reservations and information systems, fleet planning, aircraft maintenance and staff training.

SAS/FINNAIR IN NORDIC ALLIANCE

Late October Finnair and SAS signed a comprehensive agreement of cooperation to create a competitive global travel service to, from, within and via the Nordic countries. This cooperation will start with the introduction of the two airlines' 1990 summer traffic program next March 25.
