Denmark's New Government

The Danish Prime Minister Poul Nyrup Rasmussen has reshuffled his coalition, following the decision in December by the small Centre Democratic Party to withdraw from the three-party coalition.

The main portfolios in the Danish government have remained. The primary changes involve moving former Research Minister Frank Jensen to the Justice Ministry, Bjørn Wersth from Justice to Traffic, Jytte Hilden from Culture to Research and appointing a new minister - Ebbe Lundgaard - to the Culture portfolio. An innovation in the new cabinet is the creation of a super-Ministry of Food, which includes agriculture, fisheries and several consumer areas which were previously under other ministries and councils.

A new general election does not have to be held in Denmark until September 1998, although most observers expect the narrow government to call early elections sometime in 1997. Source: Nordic Council of Ministers

Dane Appointed Executive Vice President of Gillette

Jørgen Wedel has climbed to the top of one of the World's best known companies. In February he was appointed Executive Vice President of Gillette. He will be in charge of international sales and the Duracell division.

The Danish businessman started out at Braun Electric in Copenhagen, and after a career in Denmark, Germany, and England he was appointed Chief Executive of Braun International in 1991. Braun is owned by Gillette and is headquartered in Boston. In 1993 he was appointed Chief Executive of Oral-B, the world's bestselling brand of toothbrushes which is also owned by Gillette. Gillette has 34.000 employees.

Lego Races Ahead

Toymaker Lego is back on track on the US market. Whereas sales are stagnating in Europe, Lego Northamerica has managed to increase retail sales 25 pct. over the past two years, 15 pct. in 1995, and another 10 pct. in 1996. Peter Eio, President of Lego, says he is very happy with the development, especially since it is based on organic growth and 1997 is expected to be another boon year. 1997 is also the year Lego takes a big step from its traditional building bricks into the new interactive toy market. After two years' development the first Lego CD-Rom will be launched in August as part of a licensing agreement with Mindscape, one of the world's leading makers of consumer software. Finally, Lego is taking the first steps into a whole new area - children's TV. The reason being not only the move into the interactive and electronic market, but also the political development in the US. The White House and the major TV networks have agreed that every day the networks should bring three hours of children's programming of an educational nature. Lego - as a potential content provider - has already met with several production companies and sees TV as another way of strengthening the Lego image and brand. VH

Fear of Litigation

One of the great terrors of doing business in the U.S. is the fear of becoming embroiled in a long running and expensive lawsuit. There is no question that litigation costs are high in this country, where each side usually bears its own costs, regardless of the merits of the case. In addition, even when the parties have undergone lengthy pretrial proceedings, they may find themselves having to wait more than a year before the court is ready to try the action.

Naturally, there is no certain way to prevent litigation, and it is sometimes, of course, the only possible way in which to enforce one's legitimate rights. However, if the parties wish, they can agree to arbitrate. While mediation is an attempt to assist the parties in renegotiating their differences, an arbitration award is binding upon the parties. The arbitration process is swifter and less costly than litigation in court, and there are permanent arbitration institutions, such as the American Arbitation Association, which provide appropriate facilities and arbitration panels.

An arbitrator is not bound by principles of substantive or procedural law in the same manner as a court. He may do justice as he sees it, applying his own sense of law and equity to the facts of the case. The award may well reflect his interpretation of the spirit rather than the letter of agreement.

A major benefit in arbitration is that once an award has been rendered, the matter is over and done with, and not subject to endless appeals. In the U.S., the courts will only in extremely rare cases disturb an arbitral award. Only where the arbitrator has rendered a completely irrational

decision, or shown manifest disregard of the law or public policy, or where there has been misconduct, will the courts step in.


Thanks to the Federal Arbitration Act, an arbitration award can be rendered into judgement anywhere in the United States, and thanks to the International Convention on the Recognition of Foreign Arbitrat Awards, an award rendered in any one of the signatory countries can be rendered into an enforceable judgement in any one of the other signatory countries. Both the U.S. and Denmark are signatories to the Convention.

It is important to know that the parties can agree beforehand to arbitrate any disputes, before they arise, by inserting an arbitration clause in their contract. By doing so, either party can prevent litigation in court of any dispute arising under the contract. The court must in such a case refer the parties to arbitration, if either side objects to having the matter tried by a court.

Arbitration is not painless litigation, but it may provide some relief in an unhappy situation.

ISS Sold for 1 Dollar

ISS has finally sold its US subsidiary for the sum of 1 (one) dollar. The transaction was completed in January. The buyer is the reclusive British billionaire Michael Ashcroft. Under the agreement with his company Aaxis ISS receives one dollar for the share capital of ISS Inc. ISS also gets 19.5 pct. of the share capital in Aaxis - a holding company with ISS Inc.'s liabilities. The sale has been characterized as the worst Danish company transaction of a decade. Just a year ago the book value of ISS Inc.'s activities were listed as more than one billion DKK. Earlier estimates concluded that ISS would receive at least 6-700 million DKK for the problem-ridden subsidiary. According to an analysis published in the newsletter Mandag Morgen the deal values ISS at 17.4 million DKK. VH

More ISS Trouble

ISS has lost another member of its management group. CEO Jorn Wendel Andersen has quit, slamming the door on his way out, citing "disagreement about areas of considerable strategic importance". He did so a month after the controversial sale of the US subsidiary and only two weeks before he was to present the long anticipated financial results from ISS - the first after the alleged fraud at and sale of ISS, Inc. The wording of the notification - which was Wendel Andersen's choice - to the public and the stock exchange is considered unusually strong. Analysts conclude, that he either finds the sale of the US subsidiary premature and damaging to the concern, or he is dissatisfied with the way the US crisis has been dealt with in the books and the decision to sell to Aaxis. With the dramatic departure of the chief number cruncher, six members of the management group have left ISS since Waldemar Schmidt took the reins as new CEO after Poul Andreassen. But contrary to the other five - among them Wendel Andersen's highly respected predecessor Lise Friis - Wendel Andersen was hired by Schmidt and considered one of his team. VH

Henrik Slipsager Returns

The former CEO of ISS, Inc., Henrik Slipsager, has returned to the US with a vengeance as Head of the New York operation of American Building Maintenance - ISS Inc.'s main American competitor. For a while Slipsager was tagged as the next Mr. ISS after Poul Andreassen, but lost out to Waldemar Schmidt. In the bitter struggle of where to place the blame after the trouble - such as underfunded selfinsurance programs and downright fraud, Slipsager was named, and the relations between him and his former company deteriorated even further. VH

Bukkehave Skirts Political Scandal

The Svendborg-based company Bukkehave that specializes in sales of special vehicles to developing countries, has been named in connection with the much heated debate about illegal fundraising by the democratic party.

Warren Meddoff, Bukkehave Inc.'s Export Manager. offered President Clinton \$5 million at a Miami fundraiser before the election - albeit not on behalf of Bukkehave but a Texan business man who wanted tax exemptions and a letter from the President in return. Meddoff also sought to persuade the President to lift the ban on humanitarian aid to Cuba after a hurricane. Meddoff got the President's attention and was subsequently contacted about the contribution by his former senior aide, Harold Ickes, who has since left and is under suspicion for - as a member of the White House staff - illegal fundraising for the presidential campaign. According to Meddoff, Ickes is lying when he denies having asked him to shred a questionable fax. VH

SAS Reports Slump in 1996 Profits

Scandinavian Airlines (SAS) reported a 31 percent slump in 1996 profits, and the company predicts that competition is likely to get even tougher in the Scandinavian sky in 1997. The airline reported a pre-tax profit of 1.82 billion DKK (USD 246 million) for 1996. "Disappointing," said analysts.

With eight new airlines entering SAS' market in 1996, the company's forecast for the future was downbeat. "Competition in the airline industry is expected to intensify further in 1997, which could lead to a large over-capacity putting pressure on prices and revenue," the airline said in a statement.

As the designated Culture Capital for 1996, Copenhagen spruced itself up, renovated existing treasures and added some new ones - from the performing arts center created at the former Holmen naval base, the new Arken Museum of Modern Art, to underground sound gallery at City Hall Square, and an art/photography center to attract Scandinavia's trendiest artists.

More than 4 million people attended the "96" events in the initial 6 months of 1996. The city's image received a media boost, and more than 3000 articles on Copenhagen 96 were recorded in newspapers and magazines in 34 countries as well as 1600 television reports.

Nordic TV in the US

The Scandinavian Channel has begun transmissions in the United States, providing four hours of Nordic television programs per day to viewers in North America. The Nordic Council of Ministers has provided extensive support for the project, which draws programs from the public broadcasters of the Nordic countries. The programs are re-transmitted with subtitles through the offices of TCI - the world's largest cable operator - in co-operation with Norwegian owned Steinco Inc. in Denver.

Initially, the channel targets some 3 million homes, with 20 million households expected to be connected to the network by the year 2000.
