HIGHTECH SCANDINAVIA

Scandinavia is the most wired region in the world. With cellular phone penetration ranging from 43% to 65% and Internet access quickly surpassing 50%, the region represents an attractive market for advanced Internet, information technology and high-tech industries. The Danish American hightech business consulting firm Proximity will, at the Internet World Conference, October 4-8, 1999, at Jacob Javits Center, host a special session entitled "HIGHTECH".

"We want to raise awareness in the U.S. about the advanced state of the Internet, information technology and telecommunication throughout Scandinavia. This is an effective platform for some of our leading thinkers, experts and entrepreneurs to share their views," said Gitte Pedersen, president of Proximity. "We will take a look at the future of information technology in a society that is quite possibly the most computer literate market in the world, a place where everyone has the proper background to use it for business, education and entertainment". The Scandinavian region is enjoying a particularly robust economy and provides a wealth of opportunities for American companies looking to expand into Europe and the Baltic regions. A.P. Moller Takes Over Sea-Land

The Danish shipping line A. P. Moeller (Maersk) has acquired the largest US line, Sea-Land, at 800 million dollars. The deal makes Maersk Line the world's largest shipping company with 250 ships and 500,000 containers globally, double the size of most competitors. The deal is expected to clear the obligatory US and EU antitrust review by the fourth quarter of this year. The two companies entered a vessel sharing agreement in 1991 and have been co-operating closely ever since. But according to officials close to the deal, the current co-operation had exhausted its potential for rationalization and efficiency gains. Therefore, an acquisition was the next logical step, and rumors of a takeover have been circulating for years in the shipping industry.

Sea-Land's parent company, CSX - one of the largest intermodal transportation companies in the US - will now focus on its core business, i.e. railroads. Maersk's takeover of Sea-Land is the latest in a series of consolidations in the shipping industry which has seen at least 14 mergers or acquisitions in the last two years. The takeover will likely spark a new round of consolidations as competitors scramble to meet the challenges from the new giant company. EK

Superfos "Sold" to American Company The American Company Ashland announced Wednesday, September 29, 1999, that it has come to an agreement on a price with the chairmanship of Superfos. What does that mean? Ashland agreed to increase the offer to the shareholders of Superfos to DKK 160 per share provided Superfos' Board of Directors recommends the shareholders accept the offer when it is presented to them. The Superfos chairmanship will recommend to its Board that they endorse the offer to shareholders. "We believe this will clear the way for the acquisition to occur", said Mr. Charles F. Pitts, Sr. Vice President of Ashland and President of APAC, its road construction division. However, Superfos' decision to sell to Ashland has caused turmoil in the Danish organization. Peter Højland, Managing Director, and Superfos' management team have strongly disagreed on the terms of the sale and at a meeting with the Board of Directors it was decided to fire Peter Høiland. Under the terms of his contract he will receive 15 million DKK - three years salary. BM

Axel Salto Exhibition in New York

Antik, 104 Franklin Street, a gallery in TriBeCa specializing in Scandinavian decorative arts of the 20th century, announces its first show this fall. The exhibition will feature ceramics by Axel Salto, a renowned Danish artist who worked at Royal Copenhagen Porcelain from 1931 – 1961, creating a sculptural stoneware inspired by nature and mythology which was considered well ahead of its time. Salto's wildly imaginative ceramics were acclaimed during his lifetime, earning awards at exhibitions in Paris and Milan. The show affords an opportunity to view and purchase rarely seen works, highly sought after in today's market, presented beside original drawings as well as classics from the Danish modern movement in furniture. The exhibition, entitled "Forces of Nature", is being presented in collaboration with Naja Salto, Axel Salto's daughter and an artist in her own right, and Jørgen Dalgård, an established dealer and expert on Danish porcelain in Copenhagen. The show runs from October 28 through November 18, with a reception October 27 to be opened by Deputy Consul General, Anne Steffensen of the Danish Consulate and attended by Naia Salto.
