Danes Reject the Euro

On September 28, 2000, the Danish voters firmly rejected the European single currency with 53.1 per cent votes against the Euro and 46.9 in favor. It was a record turn-out of more than 85 per cent of 4 million eligible voters.

It is expected that this decision will have a substantial impact on the two other EU nations outside Emu. especially Sweden. Denmark's rejection of the euro will probably reinforce already negative curo sentiment in Sweden and make the Swedish referendum on the single currency more uncertain.


There is great uncertainty as to the date when the UK will enter Emu. and after the result of the referendum in Denmark, it is expected that the "no" camp will maintain their lead. It will probably also mean the pro-EU side in Norway will have a harder time to schedule a new EU referendum.

#### Scandinavia House: The Nordic Center in America

On October 17, 2000, The Scandinavia House opened in New York. An elegant and distinctly modern 28,000 square foot building, designed by internationally renowned architect James Stewart Polshek, the house is intended to serve as a link between the U.S. and the Nordic countries. representing nearly every aspect of Scandinavian culture, from visual arts, music and literature to business, finance and technology. It will also serve as a permanent home to its founder, the American-Scandinavian Foundation. Attending the opening were Her Royal Highness Princess Benedikte, Norwegian Princess Martha Louise, King Carl XVI Gustaf and Queen Silvia of Sweden, as well as ministers from the governments of Denmark, Sweden, Norway, Finland, and Iceland. **DACC Members Visit Maersk** 

October 12th Maersk, Inc., New Jersey, extended its hospitality to the members of the DACCNY with a tour of the 266-acre Maersk Sealand Container Port Terminal Facility at Port Elizabeth, New Jersey. The members were advised of plans to expand the facilities to 350 acres (including an expanded 70-acre on-dock rail terminal), with 6000 linear feet of berth. It is anticipated that the facilities will handle 1.2 million 20-foot container volumes, and employ, directly or indirectly, over 38,000 people in the New York-New Jersey area.

The tour of the terminal was followed by lunch at the facilities dining room overlooking the terminal and continuation of the excursion to the handsomely designed Maersk, Inc., headquarters at Giralda Farms, NJ. At Macrsk headquarters. over coffee and cake, Tommy Thomsen. President of Maersk, Inc, gave the members an informative overview of Maersk Inc., its growth, current activities and future plans. # Danske Bank A/S and RealDanmark A/S

On September 28th DACC had a seminar on Business Immigration Law.

The following is an except from that event: Work Authorization in the U.S.

There are a number of visa options available to foreign workers who wish to obtain temporary or permanent employment in the United States. At a recent talk at the Danish American Chamber of Commerce, I provided an overview of the various nonimmigrant (temporary) and immigrant (permanent) visa categories that are of most interest to Danish citizens.

Nonimmigrant work visas permit foreign nationals to enter the United States for a limited period of time in order to work for a U.S. employer, or a U.S. affiliate or subsidiary of a foreign corporation. There are several work visa categories that are relevant for Danish citizens, including the H-1B visa (for professional workers holding at least a U.S. Bachelor's degree or equivalent), the E-1 visa (for international treaty traders), the L-1 visa (for intracompany transferees), and the O-1 visa (for persons of extraordinary ability in their field). In addition, the B-1 (business visitor) visa is available for persons seeking to enter the United States to attend business meetings or conferences; Danes

may enter the United States as business visitor a waiver program without a visa for period a may enter the United States as outsiness visitors a the visa waiver program without a visa for period of

up to 90 cays.

There are also work opportunities in the United State of the United St There are also states available to certain students, researchers and come to the U.S. on F-1 (student), and States available to come to the U.S. on F-1 (student) viscos (for certain trainees and researchers) or J-1 visas (for certain trainees and researchers) visas entering the United Co. Foreign nationals entering the United States to study must generally demonstrate that they possess the funds available to pursue their studies without the funds available to pursue their studies without the need to work in the United States. Nonetheless there are possibilities for foreign students to work in the United States under certain circumstances In many cases, foreign students in the U.S. may work while they study (under certain conditions) and obtain work authorization for a period after in their area of study. Work authorization depends on the visa type and the education they are pursuing. I would recommend that students and exchange visitors speak with their school's international student/scholar adviser regarding opportunities for work authorization, as each person's situation is different. I do not recommend following "good advice" from friends and professors.

Immigrant visas permit foreign nationals to obtain permanent residence in the United States, sometimes referred to as the "green card." (The card was actually green some years ago, but is no longer, however, the term has stuck, and the latest version of the permanent resident card incorporates a green stripe on the back.) As a general rule, you can obtain permanent residence based on family ties, based on employment, or on the basis of having been granted asylum or refugee status. Danes marrying U.S. citizens should be certain to obtain legal advice before their marriage, as the timing and place of the marriage can determine whether or not the Danish spouse can easily come to the U.S. and live with his or her spouse as a permanent resident.
